#### **Cure Time**

Cure time depends upon humidity and the thickness of the material being bonded. Accomplish cure by exposing to atmospheric moisture and may take longer in dry air. Cure occurs at any level above 20% relative humidity. Cure continues for several days until acetic acid odor has disappeared.

Note: Some bonding applications may require the use of a primer. NuSil Technology SP-120 is recommended.

#### **OPERATING TEMPERATURE**

The operating temperature range of a silicone in any application is dependent on many variables, including but not limited to: temperature, time of exposure, type of atmosphere, exposure of the material's surface to the atmosphere, and mechanical stress.
