INSTRUCTIONS FOR USE

Mixing

Add 2.50% crosslinker and 0.50% catalyst by weight to the base material and mix thoroughly for two minutes. Airless mixing, metering, or dispensing equipment is recommended for production operations. If mixing by hand, take care to minimize air entrapment.

Vacuum Deaeration

Remove air entrapped during mixing by common vacuum deaeration procedure, observing all applicable safety precautions. Slowly apply full vacuum to a suitable container of at least four times the volume of material being de-aired. Hold vacuum until bulk deaeration is complete.
