## INSTRUCTIONS FOR USE

Stir well before using. Apply with pad or screen printing equipment. Adjust viscosity to match the application method. Multiple coats may be required for specialized applications. Take care to ensure that layers have not completely cured before applying subsequent coats.

Note: Some bonding applications may require the use of a primer. NuSil Technology's MED-160 is recommended. For more information on primer selection, visit [www.nusil.com](http://www.nusil.com) and review [Choosing a Silicone Primer/Adhesive System](#).

### Storage

This material cures in the presence of atmospheric moisture. It is recommended that an inert gas, such as Argon or Nitrogen, be used to blanket the product before re-sealing the container.

### Solvent Addition

MED-6608-2 is dispersed in xylene and its viscosity may be reduced by adding compatible moisture-free solvents. Among these solvents are xylene, toluene, hexane and VM&P naphtha. Mix without introducing moisture from the air into the coating. Accomplish proper mixture by agitation in a closed container on a commercial paint shaker.

Warning: Consult the MSDS for MED-6608-2 prior to use, as its solvent carrier is hazardous.
